G'day eh:

A WORD FROM THE PRESIDENT...As many of you know, a special committee has been formed to study the possibility of incorporating OVLR. The purpose of this exploration is to determine the advantages and disadvantages of incorporation as a non-profit corporation. The main reason for incorporation is protection against liability claims against OVLR'S officers and members. Forming a non-profit corporation is an option that could be considered to protect individual members and their possessions from liability claims, in case of an accident during, or related to club activities. The possibility of a lawsuit exists.

Under incorporation OVLR's assets would be held by OVLR rather than individuals.

It has to be understood that *OVLR* has an excellent safety record. Precautions are always taken to ensure that members are made aware of potential dangers and what to do in case of an accident. The label, *club of four-wheel drive enthusiasts* may sound like a risky group to outsiders. As the vehicle itself, our club membership is rather peculiar. In the history of the club, no major accident has occurred. Moreover, people in this club generally act in a responsible manner (perhaps because the average age of our club members is certainly higher than for the typical four-wheeling club). The last thing I want is to sound alarming! When we think about the future, we must reduce the risk of accident to individuals to the absolute minimum. We have learned a lot about safety over the past ten years. If we use our experience and commitment to safety, the risk of accidental injury is very low.

Incorporation would involve higher membership rates and a lot of work for special fund raisers, therefore less time and money to have fun. In addition, this could cause a membership loss, hence less folks to share the bill with. After the club becomes incorporated, then we can think about insuring our ourselves against liability and loss. Our assets are valued at \$8000-10000 (Of course the trailer is already insured.) According to the lawyers we met with on July 21th, the cost of incorporation would probably range in the \$1400-\$1500 bracket with taxes. This sum could be greatly reduced if we did most of the work ourselves Members with legal and/or accounting skills are welcomed! Annual bookkeeping fees could probably be kept under \$200 including taxes and the cost of insurance would be around \$400 per annum.

In short, either we keep some money aside and wait a few years, or we incorporate sooner and spend the bucks. Something to think about... But, believe me, there is no reason to panic.

31 JULY OFF-ROAD EVENT... Saturday arrived with glorious weather and the chance for OVLR members to participate in some light off-roading at 'Doc' Dolan's spread in Almonte. Even Rob Ferguson's three cylinder pick-up found it could handle the trail in its current state.

The challenge being diminished, the adventure seeking crew returned to Doc's for a little of the traditional beer, and questioning of Ted on how he has managed to not get stuck, thus far, in any off-road event this year, while everyone else has managed to do so at one point or another.


